ALBERT EINSTEIN ONCE OBSERVED THAT "IN THE MIDDLE OF DIFFICULTY LIES OPPORTUNITY". WALTON COUNTY IS IN THE MIDDLE OF A SIGNIFICANT DOWNTURN IN OUR LOCAL ECONOMY. WITH THE REAL ESTATE BUBBLE BURST AND NEW DEVELOPMENT MERELY CREEPING ALONG, THE COUNTY'S NUMBER ONE ECONOMIC ENGINE HAS COME TO A STANDSTILL.

THE TAXPAYERS ASSOCIATION HAS SEIZED THIS OPPORTUNITY TO CHALLENGE COUNTY OFFICIALS WITH A CALL FOR LEADERSHIP. A CALL FOR LEADERSHIP TO ENSURE THE LONG TERM FINANCIAL SOUNDNESS OF WALTON COUNTY WAS SENT TO COUNTY OFFICIALS ASKING THEM TO REDUCE SPENDING IN THEIR 2008/2009 BUDGETS TO REFLECT THE ECONOMY. OLD MODELS NEED TO CHANGE. RECURRING COSTS CAN BE REDUCED TO CUT BUDGETS PERMANENTLY. WE NEED NEW SOLUTIONS, INNOVATION AND CREATIVITY TO BREAK THE MOLD IN GOVERNMENT SPENDING.

IN PREVIOUS YEARS, WE FOCUSED ON CUTTING PROPERTY TAXES. THE REAL ESTATE BOOM THROUGH 2005 GENERATED TAX REVENUES EQUIVALENT TO WINNING THE LOTTERY. COUNTY GOVERNMENT SPENDING GREW IN SYNC WITH REVENUES. LOCAL GOVERNMENT WAS ABLE TO "CATCH UP" WITH

NEW BUILDINGS INCLUDING SCHOOLS, INCREASED PERSONNEL, MODERN TECHNOLOGY AND INFRASTRUCTURE. LARGE RESERVES WERE AMASSED FOR COUNTY PROJECTS, SCHOOLS, EMERGENCIES AND UNDEFINED NEEDS.

WITH BUDGET SHORTFALLS THIS YEAR, OUR FOCUS IS ON SPENDING, LIMITING, REDUCING AND ELIMINATING EXPENSES WHEREVER POSSIBLE. THERE ARE RECORD NUMBERS OF FORECLOSURES IN OUR COUNTY AND PEOPLE ARE STRUGGLING TO PAY FOR HOUSING, FOOD AND GASOLINE. COUNTY LEADERS MUST STEP UP TO THE PLATE AND REFLECT THESE DIFFICULT



ECONOMIC TIMES WITH A HEFTY DOSE OF FISCAL DISCIPLINE IN THEIR 2008/2009 BUDGETS.

DEAR VOTERS OF WALTON COUNTY:

WITH THE PRIMARY ELECTION COMING UP ON AUGUST 26, 2008, I WANT TO REMIND VOTERS OF SEVERAL IMPORTANT DATES AND ISSUES:

JULY 28, 2008—BOOK CLOSING FOR THE PRIMARY ELECTION. YOU MAY NOT REGISTER TO VOTE IN THE PRIMARY ELECTION OR CHANGE YOUR PARTY AFFILIATION FOR THE PRIMARY ELECTION AFTER THIS DATE. YOU MAY STILL UPDATE YOUR ADDRESS, NAME, MAILING ADDRESS, SIGNATURE, AND REGISTER FOR FUTURE ELECTIONS AFTER THIS DEADLINE.

AUGUST 11 THROUGH AUGUST 23, 2008—EARLY VOTING WILL TAKE PLACE IN BOTH WALTON CO. SUPERVISOR OF ELECTIONS OFFICES, MONDAY-SATURDAY, 8:30AM-4:30PM. EARLY VOTING HAS BECOME VERY POPULAR WITH THE PUBLIC; IT GIVES VOTERS MORE FLEXIBILITY IN THEIR SCHEDULES AND TAKES THE PRESSURE OFF OF GETTING TO A PRECINCT TO VOTE ON ELECTION DAY.

FLORIDA IS STILL A CLOSED PRIMARY STATE. THIS MEANS YOU MUST BE REGISTERED IN A RECOGNIZED PARTY TO VOTE THAT PRIMARY BALLOT. THERE IS AN EXCEPTION TO THIS IN THAT A UNIVERSAL PRIMARY CONTEST IS WHEN ONLY ONE PARTY QUALIFIES CANDIDATES IN A RACE. WHEN THIS OCCURS, THAT RACE WILL APPEAR ON ALL BALLOTS IN THE COUNTY. WE HAVE 3 UNIVERSAL PRIMARY CONTESTS ON THE AUGUST 26TH PRIMARY BALLOT, SUPERINTENDENT OF SCHOOLS, COUNTY COMMISSIONER DISTRICT 3, AND COUNTY COMMISSIONER DISTRICT 5. THESE 3 RACES WILL APPEAR ON THE DEMOCRATIC, REPUBLICAN, AND NONPARTISAN BALLOTS IN THE PRIMARY. NONPARTISAN RACES WILL BE ON ALL COUNTY BALLOTS.

IT IS THE RESPONSIBILITY OF VOTERS TO KNOW THE CANDIDATES, ISSUES, AND KEEP VOTER REGISTRATION INFORMATION UP TO DATE. SAMPLE BALLOTS, VOTER REGISTRATION, AND MUCH MORE INFORMATION IS AVAILABLE ON OUR WEBSITE AT WWW.VOTEWALTONCOUNTY.COM.
